# **FAIR CHANCE EMPLOYMENT?**

Fair Chance employment is the practice of intentionally and proactively expanding opportunities for employment and upward mobility for individuals who are justice-impacted. Individuals who are justice-impacted or justice-involved are defined as those who have had contact with courts, jails, or prisons.
