

#### Valley of the Sun United Way Grant Cycle FAQ: Workforce Development

#### WHAT IS MC2026?

This is the 5-year plan announced by Valley of the Sun United Way March 26 and is built on a year-long community informed input process. The focus is on aligning United Way and community resources to achieve a set of existing bold community goals in the areas of health, homelessness/housing, education and workforce development.

# WHAT NONPROFITS AND SCHOOLS WILL BE PART OF ACHIEVING THIS PLAN?

The United Way looks to partner with nonprofit 501c3s and schools whose impact work aligns with the goals in MC2026.

## WILL UNITED WAY CHANGE ITS FUNDING APPROACH TO ACHIEVE THIS PLAN? IF YES, HOW SO?

Yes, VSUW will be is opening a competitive grant process starting September 1<sup>st</sup>. We know that we cannot do it alone and need strong community partners to continue doing amazing work. The grant(s) may be renewable.

### WHAT IS THE PROCESS AND HOW ARE DECISIONS MADE?

The grants process will be open starting September 1<sup>st</sup> and ALL applications are due September 27<sup>th</sup>. While the application is open, staff is available to support agencies with any technical assistance that they may need. For support please visit <u>ecimpact@vsuw.org</u>. Grant applications will be reviewed by a committee of volunteers that will include VSUW Board Members, experts in the field and individuals with lived experience. After reviewing the applications and rating them, the volunteer committee will convene and make funding recommendations that will be presented to our Community Development Committee for final approval.

## WHEN WILL I HEAR ABOUT FUNDING?

Funding decisions will be shared with agencies by December 2021.

## WHAT REPORTING IS REQUIRED?

Grant recipients will provide reports at least twice annually. This data will help support United Way's annual community scorecard which will focus on the progress to the goals outlined in MC2026.
