The program will promote a two-generation approach designed to remove barriers to success and give each student and family a clear path to a productive future.

This RFP represents the requirements for an open and competitive process. Applications will be accepted until **11:59 PM on October 25, 2021**.

Notification of selection/non-selection will occur by December 15, 2021. Contract terms and conditions may be negotiated upon selection of a proposal. All contractual terms and conditions will be subject to review and final approval by VSUW and will include scope, budget, schedule, and other necessary items. Submission of an application does not guarantee a contract and/or does not guarantee that VSUW will retain your services.

# **Program Overview**

VSUW is seeking the implementation of this program in the following three high needs communities located in the surrounding areas of Cartwright, Glendale, and Tempe Elementary School Districts. Please complete an application addressing your ability to provide services related to the following topics:

- Identification of students from high-need schools who come from families who can most benefit from additional support
- Experience working with children, youth, families that are on the verge of crisis (homelessness prevention)
- Assignment of a Community Resource Navigator (CRN) case manager who serves as a primary point of contact that will assess needs in a culturally competent and responsive manner to determine what services and resources will most improve program participants situation and help navigate federal, state, and local social safety net programs
- Leveraging relationships and connections to a wide variety of health and human services organizations to benefit participants involved in this program
- Implementation of a comprehensive case management tracking system to ensure students and families are moving in the right direction and getting the most from the resources and services to which they are connected
